

4. If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply
5. 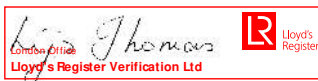

6. Production tests are to be conducted to ensure compliance with SOLAS Chapter III Regulation 5 and recorded by the manufacturer in accordance with either the approved Production Quality Assurance system (Module D), or Product Quality Assurance (Module E), or witnessed by the Notified Body (LRV) as required by the Product Verification (Module F) of the Marine Equipment Directive. This does not preclude any further testing to additional requirements of the Marine Administration of the country where the ship is registered (i.e. the flag state) or those acting on behalf of that Administration
7. Each item, batch or lot of the equipment is to be issued with a "Declaration of Conformity" and have the "Mark of Conformity" affixed after a conformity assessment module is in place
