- 4. Any dated medications in the outfit shall be replaced during periodic stripping and cleaning of the lifeboat, rescue boat, or rigid liferaft if their expiry date has passed.
- 5. The storage arrangement of the first aid kit is not part of this Design Appraisal or Certificate. All such arrangements are to be to the satisfaction of the Surveyor attending on board.
- 6. If the specified standards are amended during the validity of this certificate, this product type is to be re-approved prior to it being supplied to vessels to which the amended standards apply.
